To all users of the Lincoln Community Center:

We are very pleased to be able open the Center again and resume our services for the community. However, for the time being, we will need to operate under more controlled measures. Every attempt is being made to assure the safety of our patrons and staff. To be effective, this will require your cooperation. It is our hope that when conditions improve, we can relax some of these precautionary actions. Until then, the following requirements will be asked of everyone using the Center. Please read and initial each of the requirements below to acknowledge that you understand and will follow the guidelines stated below.

- ___ All visitors of the center will be admitted through the Ash Street (east) entrance only. We ask that anyone displaying signs of respiratory illness or fever not visit the Center. A designated staff member will immediately take the temperature of all entrants. Entry may be prohibited if the temperature is above the acceptable limit.
- ___ All patrons must follow the traffic patterns that will be marked throughout the building. We ask that you use the exit designated to the area that you are using. We ask that once you are downstairs you do not come back upstairs and that you exit from the downstairs. We ask that those using the gym exit through one of the side gym doors. All exits will be marked.
- ___ Users are encouraged to bring a face mask for use at the facility. We encourage all users to wear a mask when sharing an area with others. Users will also be responsible for bringing their own water bottles and towels. We ask that you please limit your belongings and bring only the belongings that you will need while in the building.
- ___ Social distancing (maintaining at least a six-foot distance between persons), will be enforced by staff members at all times. Seating will be spaced out and we ask that you do not move the seating.
- ___ Each area has posted protocols that will be enforced by staff in that area. Any questions about the interpretation of these protocols should be directed to the staff. We ask that you be respectful and follow these protocols for the health and safety of yourself and those around you.
- ___ Minimize the use of common touch points as much as possible. Such as, leave doors open, do not touch light switches, etc. All bathrooms and high touch points will be disinfected every two hours by staff, but we do ask that everyone practice hand washing and use hand sanitizer while in the building. Staff will use disinfectant to sterilize objects (balls, shared equipment, etc.) after being touched by others.
- ___ Users will have limited time in the building. Those using the gym and weight room will have 75 minutes to complete their desired activity. Those using the pool will have 45 minutes to complete their desired activity. These restrictions are being put in place so that we can ensure all members get a chance to use the facility.
- ___ The user agrees that LCC staff and/or its Board of Directors will NOT be held liable if a patron of the Lincoln Community Center contracts Coronavirus (COVID-19) or is injured while using our facility.

LCC reserves the right to refuse admission to anyone who does not comply with these guidelines. Our objective is to make this a safe and healthy space for everyone. Signing this agreement indicates that you are agreeing to follow these guidelines for all visits to the center until restrictions are officially lifted.
